Key Responsibilities

Capital Sky takes its responsibilities in respect of modern slavery and human trafficking seriously. Training

To ensure a high level of understanding of the risks of modern slavery and human trafficking in our supply chains and our business, we will provide training to our staff. We also require our suppliers to provide training to their staff.

To show our effectiveness in combating slavery and human trafficking We review supplychain feedback each year on this issue to ensure that slavery and human trafficking is not taking place in any part of our business or supply chains.

We also monitor trade publications and news outlets in order to better understand the risks in our industry.

Further steps

We are committed to reviewing the effectiveness of the steps we have taken to ensure that there is no slavery or human trafficking in our supply chains.

This statement is made in accordance with section 54(1) of the Modern Slavery Act 2015 and constitutes Capital Sky anti-slavery and human trafficking statement for the current financial year. It has been approved by Capital Sky Board of Directors .
